COMPANY OVERVIEW

ROLE OUTLINE

Amber is seeking to recruit a Valuations Lead to join its Finance team. The successful candidate will be an integral part of the valuation process for the 140+ investments held by the funds managed or advised by Amber. Whilst analysts and Investment Directors may sit within the Origination or Asset Management teams, the valuation processes will be owned centrally within the Finance team to ensure consistency and quality control.

The valuations represent a key part of Amber’s stakeholder materials and therefore the successful candidate will play a crucial role in enabling Amber to meet its reporting obligations in a timely and accurate manner. The successful candidate will also use their understanding of the portfolio composition to help support investment decisions by enabling a greater understanding of the impact of new investments on existing portfolios as well as working with the investor relations team to provide prompt and accurate responses to queries from stakeholders. The role will not only provide exposure to a range of infrastructure investments but also to a wide variety of workstreams and stakeholders across the Amber business.

KEY RESPONSIBILITIES

- To ensure valuation inputs are applied consistently and appropriately across the investment portfolio
- To maintain the financial models used to calculate the valuations, provide cash flow projections and assess compliance with financial covenants set out within the corporate debt facilities
- To run scenario and sensitivity analysis as required
- To ensure any material changes in valuations and/or cash flow projections are well understood such that they can be explained to both internal and external stakeholders as required
- To maintain a robust controls environment by ensuring appropriate processes are followed
- To assist auditors with the semi-annual audit of the investment valuations
- To help with preparing responses to investor questions, interim and annual reports, and investor presentations
- To work with the origination teams to enable decision makers to understand the potential impact of new investments on existing portfolios
- To assist with both internal and external reporting

REQUIRED SKILLS AND EXPERIENCE

- Good understanding of the infrastructure asset class
- Qualified chartered accountant with several years’ experience of both financial modelling and valuations
- Strong analytical and numerical skills
- Excellent verbal and written communication skills
